UNLESS THE TERM "GUARANTEED" IS SPECIFICALLY STATED IN WRITING ON YOUR TICKETS, INVOICE, OR RESERVATION ITINERARY, WE DO NOT GUARANTEE ANY OF SUCH SUPPLIERS' RATES, OVER/UNDER BOOKINGS, RESERVATIONS, CONNECTIONS, SCHEDULING, OR HANDLING OF BAGGAGE OR OTHER PERSONAL EFFECTS. TRAVELERS HAVE DONE DUE DILIGENCE, ARE AWARE OF THE QUALITY OF THE HOTEL ACCOMMODATIONS CHOSEN AND AGREE THAT THIS AGENCY WILL NOT BE RESPONSIBLE IF THEY ARE NOT SATISFIED. TRAVEL AGENT SHALL NOT BE RESPONSIBLE FOR ANY INJURIES, DAMAGES, OR LOSSES CAUSED TO ANY TRAVELER IN CONNECTION WITH TERRORIST ACTIVITIES, WAR, ACTS OF GOD, SOCIAL OR LABOR UNREST, MECHANICAL OR CONSTRUCTION FAILURES OR DIFFICULTIES, BANKRUPTCY OR CESSATION OF SUPPLIER OR CARRIER SERVICES, DELAYS, CHANGES OR CANCELLATIONS, OVER/UNDER BOOKINGS, NO SHOWS, MISSED CONNECTIONS/FLIGHTS, LATE CHECK-IN, IMPROPER IDENTIFICATION, DISEASES, LOCAL & FEDERAL LAWS, CLIMATIC CONDITIONS, ABNORMAL CONDITIONS OR DEVELOPMENTS, ACCIDENTS OR HEALTH RELATED PROBLEMS BEFORE OR WHILE IN-TRANSIT TO, DURING, AND AFTER A TOUR OR TRIP, OR ANY OTHER ACTIONS, OMISSIONS, OR CONDITIONS OUTSIDE OF K&K TRAVEL SERVICES CONTROL. TRAVELER ASSUMES COMPLETE AND FULL RESPONSIBILITY FOR, AND HEREBY RELEASES THE AGENT AND K&K TRAVEL SERVICES FROM, ANY DUTY OF CHECKING AND VERIFYING ANY AND ALL PASSPORT, VISA, VACCINATION, OR OTHER ENTRY REQUIREMENTS OF EACH DESTINATION, AND ALL SAFETY AND SECURITY CONDITIONS OF SUCH DESTINATIONS, DURING THE LENGTH OF THE PROPOSED TRAVEL. IT IS THE PASSENGER'S RESPONSIBILITY TO HAVE PROPER PASSPORTS OR GOVERNMENT ISSUED IDs WHERE PERMITTED.
